I understand that the Fun Run track is a public pathway, managed and maintained by the City of Fairhope, and therefore can not be closed for private use. I will obey any and all traffic laws which apply to this track and will maintain awareness of my own person and any minors I have in my care. I assume all risks associated with participating in this event, including but not limited to: falls, contact with other participants, the effects of the weather, including extreme temperatures and/or humidity, traffic and the conditions of the road, and natural wildlife along the course.

I attest that I have read the rules of the event and agree to abide by them:

- No roller skates, roller blades, skateboards, or scooters allowed on the course
Children under 19 must have a waiver signed by a parent or guardian in order to participate
Children under 16 must be accompanied by an adult at all times
Participants must move to the side for any approaching vehicles
To maintain a family atmosphere, participants will refrain from using any lude / harassing language and/or gestures
Participants will not approach, coerce, feed, or handle any wildlife found along the event course

I understand failure to comply with these rules, and any additional rules established for my safety, or the safety of others will result in event officials / organizers reserving the right to suspend my participation in the event.

Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Big World Bash Fun Run-Walk, the city of Fairhope, and Children of the World, Inc., all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver.
